Thanks again for your letter of acknowledgement sent me yesterday in response to my reminder.

However, two important things need straightening out:

Contrary to your letter, I didn't deliver a **complaint** against the **JSC** under section 77A of PAIA for investigation under **section 77E** (cited in your letter).Rather, I **requested an assessment** of the **OCJ** for its compliance with PAIA under **section 77H**.*Completely different processes -- a request, not a complaint.**Completely different public bodies -- the OCJ, not the JSC.*

Please send me your corrected acknowledgement.

If requests made under section 77H are allocated different kinds of reference numbers from complaints made under section 77A, please provide me with a fresh reference number for future follow-up and action if need be.
