Dear Mrs Sonca

I attach a letter for the personal attention of JSC Chairperson, Mandisa Maya CJ.

It concerns my impeachable judicial misconduct complaint against Basheer Waglay, retired Judge President of the Labour-and Labour Appeal Courts, filed over seven-and-a-half years ago, and still undecided.

Paragraphs 98 and 100 give the point of my letter:

98. But having been apprised by this letter of the JCC's outrageous, illegal and unconstitutional delay in dealing with my supremely impeachable Complaint against Waglay JP, please advise me by 30 March 2025, two months hence, as to when I can expect the appointment of a Judicial Conduct Tribunal to try it under section 16 of the JSC Act. (If more time is needed to consider the matter, I'll gladly agree to any reasonable extension request.)

100. Now that you've succeeded Zondo CJ as JSC Chairperson and have your eye on the case I'm hoping my Complaint will be dealt with 'diligently and expeditiously' from here on, and that I won't need to sue the JSC to compel this, more than seven-and-a-half years since I lodged it.

Please would you:

- (a) acknowledge receipt of this email, and
- (b) let me know when you've printed my letter for Maya CJ and handed it to her.

You'll appreciate that the matter is extremely important.
